Strategically located within the industrial area of Dali, the property is situated approximately 1.1 km from the core of Dali Industrial Area, 2.3 km from Nisou Industrial Area, 2.9 km from the Nicosia-Limassol Motorway (A1), 4.2 km from Dali Municipality Centre, 6.6 km from the University of Cyprus, 7.4 km from the GSP Stadium, 7.8 km from Nicosia General Hospital, 9.8 km from Geri Industrial Area and approximately 13.1 km from Nicosia City Centre. These distances provide excellent connectivity to major transportation networks, industrial infrastructure and key business destinations throughout Cyprus.

The combination of its extensive land area, advantageous industrial zoning, registered road access and strategic location makes this property a rare opportunity for investors and businesses seeking a high-potential industrial asset with strong future growth prospects.
