Although the field is currently landlocked, its strategic position within a well-established industrial district creates significant future value and investment prospects, particularly for purchasers seeking industrial land within a continuously expanding business and logistics corridor.

The property enjoys a prime location approximately 1.4 km from the core of Dali Industrial Area, 2.8 km from Nisou Industrial Area, 3.5 km from the Nicosia-Limassol Motorway (A1), 4.9 km from Dali Municipality Centre, 7.2 km from the University of Cyprus, 8.1 km from the GSP Stadium, 8.4 km from Nicosia General Hospital, 10.7 km from the Industrial Area of Geri and approximately 14.2 km from Nicosia City Centre. These distances ensure excellent connectivity to major transportation networks, industrial infrastructure and key commercial destinations throughout Cyprus.

The combination of its extensive land area, strategic industrial zoning and location within one of Nicosia's fastest-growing industrial regions makes this property an outstanding opportunity for businesses and investors looking to secure a high-potential industrial asset with significant future appreciation.
